

## Eligibility Requirements for the Schlott Family Scholarship

- This is a 4-year scholarship available to anyone attending college.
- The applicant must be accepted to an accredited school of higher education.
- The applicant must be both a full time student and a freshman.
- The applicant is required to maintain a college GPA of 2.5 at the end of each year in order to receive the following years award. A college transcript will be provided as proof that the grade requirement has been met.
- The applicant shall attend church regularly.
- The applicant shall maintain high moral standards.
- The applicant who has shown persistent effort and achievement based on individual ability rather than grades earned will be considered along with those with higher academic achievement.
- The applicant must submit the following:
  - A. A personal and financial information form.
  - B. One personal reference form.
  - C. One Instructor reference form.
  - D. A copy of your secondary school transcript.
  - E. IRS Income Tax reports for the previous year-both yours and your parent's.
- The applicant who is majoring in the field of economics could have the advantage in the event of two applicants being equal.
- The scholarship recipient shall attend the presentation of the award during a regularly scheduled church service.

NOTE: All material relative to financial need will be destroyed once applications have been processed.
